INTRODUCTION OF VISITORS - Gloria Grehl was present at the start of the meeting.

Mr. Kiebzak stated that Items D., E., F., and I. have been corrected by the owners, so there is no action for the Board to take on those matters.

Items A., B., C., G., and H. - A motion was made by Mrs. Bussinger and seconded by Mrs. Jarvis to instruct Mr. Kiebzak or Mrs. Bussinger to obtain a commitment from the owners to correct the deed restriction violations within a two week time frame or a time frame at the discretion of the Manager or the Board President, otherwise their cases will be sent to the Association's attorney to initiate legal action to compel their compliance. The motion was unanimously approved.

PRESIDENT'S REMARKS – Mrs. Bussinger said that she made contact with the liaison from the Orlando Police Department, who is assigned to Commissioner Burn, and was able to arrange for the Association to receive the weekly crimes statistics report.

MINUTES – A motion was made by Mrs. Steinhardt and seconded by Mrs. Hawks to accept the minutes of the July 21, 2020, Board of Directors' meeting. The motion was unanimously approved.

FINANCIAL REPORT - Mr. Kiebzak reviewed the July, 2020, financial statement and the Financial Report dated August 18, 2020.

Unit 356/5382 Elm Court/AC Conduit/Request a Variance – A motion was made by Mrs. Bussinger and seconded by Mrs. Steinhardt to require that the owner run the electrical service in order to be in compliance with the cable guideline. The motion was unanimously approved.

Unit 413/5351 Bamboo Court/ Remove Palm Tree Stump on Patio/ Pay Legal Fees and Costs, Cable – Mrs. Bussinger stated that if she cannot obtain a commitment from the owner by August 20, 2020, then she will tell Mr. Kiebzak to instruct the Association's attorney to take action to compel the owner to correct the violation, and to pay the legal fees and costs associated with this action and the action related to removing the cable.
