## BOARD OF DIRECTORS' MEETING MINUTES

February 21, 2017

The meeting was called to order at 7:00 PM.

INTRODUCTION OF VISITORS – There were no visitors at the start of this meeting.

A. Unit 729/Architectural Review Application – A motion was made by Mr. Palmisciano and seconded by Mr. Alivento to allow the owner of Unit 729 to install one camera as specified in her email dated February 2, 2017, with dimensions not to exceed 3.29 inches wide by 4.23 inches tall by 3.54 inches deep. The owner will be required to use a professional contractor who specializes in this field and who will have the authority to install one camera on the exterior of Unit 729 with the exception of placement on the mansard styled siding or the roof. The owner will be responsible for protecting or removing this camera if the Association is required to maintain, repair, or replace any portion of the exterior of the building considered to be a common element.
