The motion was unanimously approved.

#### **NEW BUSINESS**

- A. Election of Officers A motion was made by Mr. Alivento and seconded by Mr. Diaz to elect Mrs. Bussinger to serve as the President of the Association, to elect Mr. Alivento to serve as the Vice President of the Association, and to elect Mrs. Steinhardt to serve as the Secretary/Treasurer of the Association. The motion was unanimously approved.
- B. Proposed Operating Budget/ July 1, 2012, to June 30, 2013 The Board discussed the draft of proposed budget. Mr. Kiebzak is waiting for the completion of the Reserve Study in order to have the amount for annual reserve contribution.
- C. Sidewalk/5276 Cypress Court The Board unanimously agreed to allow the addition of a small sidewalk that will complete the connection between two other sidewalks as is shown on an original plat.

A motion was made by Mr. Alivento and seconded by Mrs. Steinhardt to adjourn the meeting at 8:02 PM. The motion was unanimously approved.
