#### **NEW BUSINESS**

B. Use of Balconies – Mr. Kiebzak has written letters to residents asking them to remove all items being stored on the balconies. He said that there has been a positive response to this request. He discussed this topic with Mrs. Bussinger who asked that it be put on the agenda for discussion by the Board. The rules and regulations provide some flexibility to adopt a standard in terms of what is allowable. The Board has the final say as to what is unsightly or hazardous and may determine that something shall not be permitted solely on the basis of safety or aesthetic reasons. There might be an item not specifically identified in the body of the rules and regulations appearing on a balcony. Mr. Kiebzak will make the Board aware of the item in order to obtain a determination on whether or not it is allowable.
