B. Light Fixture/No Power – Mr. Kiebzak reviewed the Manager's Report dated February 16, 2016. The consensus of the Board was that Mr. Kiebzak will contact the owners of the units who supply power to the exterior light fixtures and request that they repair their electrical systems, so that power is restored to the fixtures.

C. Pool Deck – Mr. Kiebzak reviewed the Manager's Report dated February 16, 2016. The Board of Directors took no action on this item.

Mrs. Alivento and Mr. Palmisciano volunteered to shop for pool furniture, and bring their ideas back to the Board of Directors.
